Course Description

The current EU-UK Trade Cooperation Agreement has highlighted the complexity for Irish importers and exporters when trading with a third country. A tariff-free quota-free trade agreement cannot operate without complex product Rules of Origin requirements. This course aims to teach business to manage these rules within their own organisation, and how to remain compliant with customs and tax authorities when claiming preferential origin on their product.

Understanding customs Rules of Origin can reduce your exposure to expensive customs duties and create new investment opportunities to expand your existing manufacturing and sourcing or distribution operations.

Course Content

The course content will deliver a solid understanding of the concept of product origin in global trade. It will also look at very specific rules and processes that allow importers and exporters to navigate this sometimes-complex topic, in an organised and compliant manner. The course outline is as follows:

- The origin concept in global trade
- Importance of origin in global Free Trade Agreements – specific focus on EU-UK Trade and Cooperation Agreement
- Non-Preferential and Preferential Rules of Origin & how to determine the origin of your product for customs purposes
- Types of preferential arrangements – calculating origin based on cumulation & tolerance rules
- Origin information to include on your customs declarations
- Proof of Origin for customs authorities and compliance with EU customs law
- Binding Origin Information (BOI) – how to get legal certainty of your origin calculations

Learning Outcomes

- Demonstrate an understanding why the origin of goods is important to customs
- Distinguish between preferential origin and non-preferential origin
- Explain the concept of binding origin information & origin labelling
- Determine what proof of origin is needed for customs authorities and where to obtain these
- Demonstrate an awareness of preferential trade arrangements and how they work; including how product origin can affect your sourcing and manufacturing operations/locations and how to turn these rules into a competitive advantage
- Demonstrate an understanding of what a business must know to remain compliant
- Apply rules of origin to their respective business
